CORRECTION

Health expenditure report

There is an error in Table 26 on page 46 of the *Health expenditure Australia 2000-01* report as published.

The estimated total expenditure on health is unaffected by the error.

Our corrected figures show that individual spending on medical services rose by 0.3% in real terms in 1999-00 instead of declining by 10.1%.

A corrected table is reproduced below, with the incorrect numbers shown crossed out in brackets.

Changes are also required to Table A10 on page 77. Individuals' expenditure on medical services is \$1,005 million (not \$901 million), and individuals' expenditure on other professional services is \$1,266 million (not \$1,370 million).
