

2 Residential aged care services

As at 30 June 2004, there were 2,932 mainstream residential aged care services in Australia providing a total of 154,487 places. Also at 30 June 2004, there were 95 Multi-Purpose Services providing 1,757 residential care places, and 29 services receiving flexible funding under the Aboriginal and Torres Strait Islander Aged Care Strategy providing 336 residential care places. At 30 June 2003, the comparable figures were 149,232 mainstream residential aged care places, 1,643 residential care places for Multi-Purpose Services and 306 residential care places for services receiving flexible funding under the Aboriginal and Torres Strait Islander Aged Care Strategy.

Because of the flexible nature of the services provided by Multi-Purpose Services and services receiving flexible funding under the Aboriginal and Torres Strait Islander Aged Care Strategy, only limited data are available on these services. Consequently, the remainder of this section presents data on mainstream residential aged care services only.

The number of mainstream services has declined since 30 June 1998 when a total of 3,015 services provided residential aged care. At the same time the corresponding number of operational places has risen from 139,917 to 156,580. This represents an increase in the average number of places per facility from 46.4 at 30 June 1998 to 53.4 at 30 June 2004.




Figure 2.1 illustrates changes in the sizes of aged care services since 30 June 1998. At this date, services with 61 or more places accounted for 20% of total services; at 30 June 2004, 28% of services had 61 or more places. There was a reduction in the number of services with 40 or fewer places from 1,590 in 1998 to 1,205 in 2002. In 1998, 53% of services were this size, while in 2004 they accounted for 41% of services (Table A1.4).

The size of aged care services differs across jurisdictions. At the larger end of the continuum are services in the Australian Capital Territory (averaging 67 places per service), New South

Wales (57) and Queensland (56). Below the Australian average for beds per service (53), were Western Australia (50), South Australia (50) and Victoria (48). At the smaller end of service size are services in Tasmania (45) and the Northern Territory (29) (Unpublished data).

Around 65% of services in the Australian Capital Territory had more than 60 places. Tasmania has a comparatively large proportion of small services with 20 or fewer places (17%). In the Northern Territory, half the services (47%) have 20 or fewer places, and there were no services with more than 60 places (Table 2.2).

To some extent these state/territory patterns are associated with geographic differences. Two-thirds of services in remote and very remote regions have 20 or fewer places and most of the remainder in these regions have 40 or fewer places. In the Northern Territory, 60% of services are located in remote and very remote regions. Services in regional areas also tend to be smaller than those in major cities. Eighty-seven per cent of services in outer regional areas and 76% of services in inner regional areas have 60 or fewer places compared with 66% of services in major cities. Tasmania has no services categorised to major city location while all services in the Australian Capital Territory are categorised as major city services (Tables 2.1 and 2.3).

3 Patterns of use

This section examines rates of usage of residential aged care, occupancy levels, length of stay and resident turnover. It also reports on admissions to and separations from residential aged care.

Usage rates

Age-specific usage rates for permanent residential aged care have been calculated for different sub-groups in the population based on the Australian Bureau of Statistics (ABS) 2001 census (estimated resident population) and ABS population projections. Overall, usage rates of residential aged care increase with age. They are higher for women than men, particularly among older age groups.

For the Indigenous population, these rates at 30 June 2004 were 19.0 per 1,000 Indigenous persons aged 65–69 years, 30.7 per 1,000 aged 70–74 years, and 100.4 per 1,000 aged 75 years and over (Table 3.4). Rates for non-Indigenous people were lower for the younger age groups (5.9 per 1,000 non-Indigenous persons aged 65–69 years, and 13.8 per 1,000 persons aged 70–74 years). The rate for persons aged 75 years and over however, was higher at 101.8 per 1,000 persons. The total usage rate was higher for non-Indigenous persons (7.3 per 1,000 persons) than Indigenous persons (1.8 per 1,000 persons).

Based on Australian Institute of Health and Welfare projections of ABS estimated resident population by country of birth, the number of Australian-born people receiving permanent care at 30 June 2004 was estimated to be 57.8 per 1,000 persons aged 75–84 years and 257.8 per 1,000 aged 85 years and over. The corresponding rates for English-speaking people who were born overseas were slightly lower at 50.3 and 253.8 respectively, and the corresponding usage rates for people from culturally and linguistically diverse backgrounds were lower still at 47.6 and 195.1 per 1,000 respectively (Table 3.3).

Resident occupied place-days

During the 12-month period from 1 July 2003 to 30 June 2004, 53.1 million place-days were used in aged care services in Australia, consisting of 52.1 million days for permanent care and just over 1 million days for respite care (Table 3.5). Just under 2% of occupied place-days were used for respite purposes. This rate varied somewhat across the states and territories, with the smallest proportions provided in Victoria (1.6%) and the highest in the Northern Territory (4.6%). The rate for respite occupied place days also varied with remoteness from 1.7% in major cities to 3.6% in very remote areas.

Occupancy

The overall occupancy rate ranged from 91% in the Northern Territory to 98% in the Australian Capital Territory (Table 3.6). Australia-wide, the occupancy rate was 96%. The

occupancy rate was 96% in major cities, inner regional and outer regional areas. It was 94% in remote areas and 85% in very remote areas (Table 3.6).

Length of stay

Two standard measurements related to length of stay are the total or completed length of stay of a separated resident up to the point of leaving residential aged care, and the length of stay of an existing resident up to a particular point in time (in this publication up to 30 June 2004). It should be noted that for existing residents, length of stay is an incomplete measure, showing the time that residents have already spent in residential aged care, but not how much more time will be spent before leaving. It also excludes residents who only stayed a short time during 2003–04 and had already left residential aged care at 30 June 2004. This latter group is, however, included in the measure of completed length of stay.

The distribution of length of stay for existing permanent residents at 30 June 2004 was toward longer periods of stay (Table 3.7). Only 8% of permanent residents had been in residential aged care for less than 3 months. About 20% had been resident for between 3 months and 1 year, 50% for 1 to 5 years and 22% for 5 years or more.

For completed length of stay, 19% of permanent residents stayed less than 3 months with 20% staying between 3 months and 1 year. Just under 42% of permanent residents stayed between 1 and 5 years prior to separation, with 19% staying over 5 years (Table 3.9).

The average (mean) length of stay for permanent residents separating from residential care from 1 July 2003 to 30 June 2004 was 164 weeks for women and 108 weeks for men. In aggregate, the average length of stay was 144 weeks (Table 3.10). The length of stay of residents at the time of separation varied among the states and territories. Permanent separations in the Australian Capital Territory had the longest average length of stay (173 weeks) and those in the Northern Territory had the shortest (126 weeks).

For those leaving respite care during the year under review, the average length of stay was 3.1 weeks, the same as the previous year (Table 3.11). Among those leaving respite care, the average length of stay varied from 2.3 weeks in Tasmania to 3.5 weeks in New South Wales and South Australia. The longest average length of stay was in very remote areas (5.0 weeks).

Since 1998–99, the overall trend for permanent resident separations has been toward increasing average length of stay (131.3 weeks in 1998–99 to 143.7 weeks in 2003–04). On the other hand, completed length of stay for respite care has declined from 3.5 weeks to 3.1 weeks over the same period (Table 3.1).

Turnover

The amount of turnover in the system is a function of the number of admissions, length of stay and the overall growth or reduction in the size of the system. Generally, the turnover for permanent and respite residents has been relatively stable over the last 6 years but fluctuates in a narrow band according to changes in these factors.

Approximately one-third of permanent places are associated with new admissions in a year, whereas respite places are used by 17 people per year (Table 3.2).

Admissions and separations

Permanent care

There were 99,988 admissions to residential aged care from 1 July 2003 to 30 June 2004, of which 53% (53,356) were for permanent care (Tables 3.1). In 1998–99 there were fewer (86,064) admissions but the same proportion (53%) were for permanent care (Table 3.1) and

(AIHW 2004a). Between 1 July 2003 and 30 June 2004 there were 95,267 separations from residential aged care. Separations after a period of permanent care totalled 48,723 which accounted for 51% of total separations. There were fewer separations in 1998–99 (85,018), but a similar proportion (52%) were after a period of permanent care (Tables 3.1 and AIHW 2004a).

For those whose destination is specified for 2003–04, 86% of those leaving permanent care died, 4% returned to the community, 5% moved to another residential aged care service and 6% were discharged to hospitals (1.5% were not clearly determined, Table 3.13). Among those who were reported as having died, 18% had stayed for less than 3 months, 19% for between 3 months and 1 year, 43% for 1 to 5 years and 20% for 5 years and more (Table 3.15). Those with shorter periods of stay were more likely to return to the community and less likely to die in residential aged care than those with longer periods of stay.

There is variation across states and territories with respect to destination on separation. The Northern Territory had the highest proportion of permanent residents returning to the community (7%). Tasmania had the highest percentage of permanent separations through death (95%), while Western Australia had the lowest percentage of separations through death (79%) and the highest proportion moving to hospital (10%) (Table 3.13).

Respite care

On 30 June 2004, respite residents made up 1.8% of all residents (Table 4.4), which is slightly lower than the 30 June 2003 proportion and the proportion of respite residents in nursing homes and hostels combined on 30 June 1997. This figure under-represents the importance of respite care, however, as it accounted for some 47% of 99,988 admissions from 1 July 2003 to 30 June 2004 (Table 3.1). This is explained by the short-term nature of respite care; while there were a large number of admissions for respite care (46,632) over the course of the 12-month period, there were relatively few respite residents at any one point in time. For example, there were 2,646 respite residents at 30 June 2004.

About 12% of respite separations had an unspecified destination on departure from residential care (Table 3.14). Of those for whom data were available, 79% returned to the community. A further 15% moved to another service, and 5% were discharged to hospitals. Deaths accounted for less than 2%.

For respite residents, state and territory variations in destination on separation were also evident (Table 3.14). After excluding those with an unspecified destination, Tasmania and the Australian Capital Territory had the highest proportions returning to the community (86% and 70% respectively), while New South Wales and South Australia had the lowest (61% and 64% respectively). Victoria and Queensland also had high proportions returning to the community (78% and 76% respectively).

A common pattern is that those states and territories with a lower rate of return to the community tended to have a higher rate of transfer to another service. Thus, in Western Australia and South Australia, 20% and 17% respectively of respite separations involved a transfer to another residential aged care service, compared with the national average of 15%.
