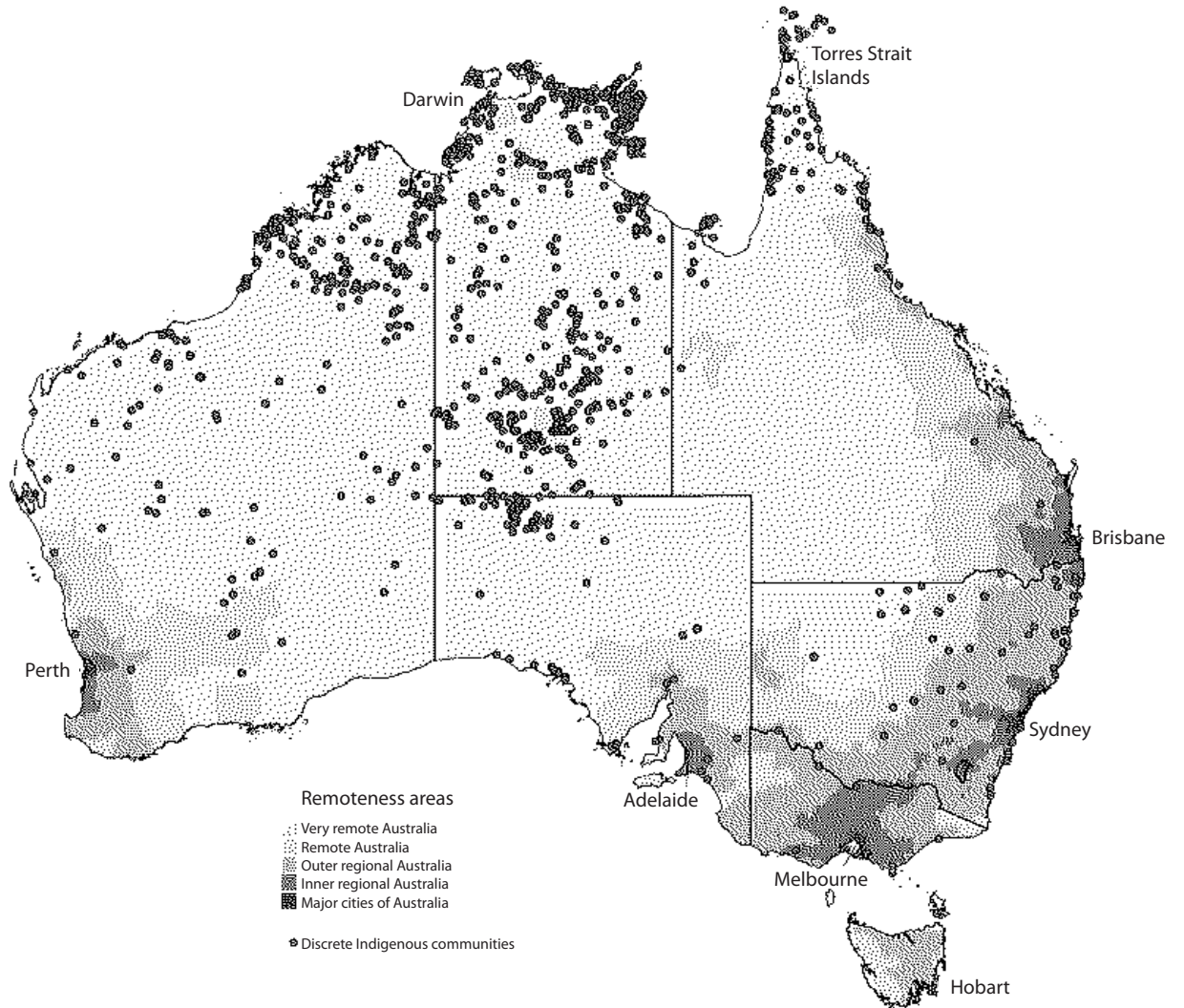


Appendix 1: Discrete Indigenous communities, by remoteness structure
