

## National targets and sub-outcome measures

The [Performance measurement Plan \(PMP\)](#) for the National Outcomes Framework groups measures into four tiers.

Tiers 1 and 2 consist of measures where an existing data source is available and data are collected at the national level. These measures are unshaded in the list below.

Tier 3 and 4 measures are those for which there is currently no available data source to measure progress. These measures are shaded in the tables below.

The PMP is a living document that will be regularly reviewed and updated as the data landscape changes over the life of the National Plan. Following the first release of the PMP, the AIHW undertook further work with data custodians to confirm what data were available for reporting. As a result, changes to some measures have been made to better reflect the data being used to report, and some changes have been made following advice of data custodians.
