International Classification of Diseases, 11th Revision (ICD-11) Updates

ICD-11 Implementation Planning: the Australian ICD-11 Task Force

The Australian ICD-11 Task Force (AITF) has held several meetings since the last published update (January 2023). The development of the Roadmap of activities required to make a decision regarding implementation of ICD-11 in Australia continues to progress. The Roadmap considers a range of potential contexts for implementation, particularly in relation to mortality and admitted care (morbidity) coding, as well as other use cases.



ICD-11 Mapping Task Force (MTF)

Following agreement at the WHO-FIC Network Advisory Council meeting in October 2021, the WHO established a Mapping Task Force (MTF) during 2022. Its first meeting was held in early 2023.

The MTF serves as an independent crosscutting working group within the WHO-FIC Network for coordination of mapping between ICD versions (e.g., ICD-10 and ICD-11) and will eventually oversee maps between ICD and other terminologies (e.g., SNOMED-CT, MedDRA, etc). The MTF will facilitate sharing of experiences between countries and regions about implementation and maintenance of maps, as well as recommend strategies to minimise mapping efforts in the future, for new maps and map maintenance.

Like CRGs, the MTF has an advisory role to the WHO-FIC Network and reports to the WHO-FIC Council. The taskforce currently has two Australian representatives, Filippa Pretty (AIHW) and Nicole Rankin (IHACPA).

Gender Incongruence and the ICD-11

Work continues with the AIHW and the Royal Children's Hospital (RCH) Melbourne on a coding exercise testing the gender incongruence section of the ICD-11. The RCH offers a Gender Service for patients experiencing issues related to gender dysphoria.

The coding team and HIMs at the hospital are continuing to work through 100 cases in a dual coding study using both ICD-10-AM and ICD-11. The results of this study are expected by the end of 2023.

ICD-11: Did you know?

What's the difference between the Foundation and Tabular Lists?

The Foundation is a multi-dimensional collection of all ICD, ICF and ICHI entities.

Entities can be diseases, disorders, injuries, external causes, signs and symptoms, functioning domains, or interventions.

The Foundation also has the necessary information to use the entities to build a tabular list, such as information on where and how a certain entity is represented in a tabular list, whether it becomes a grouping, a category with a stem code, or whether it is mentioned as an inclusion term in a particular category.

Different tabular lists can be built from the Foundation. Drawing on the same Foundation, a set of tabular lists that builds on the same hierarchical tree structure can be created – producing congruent tabular lists, that is, subsets of the Foundation for a specific use.

ICD-11 has multiple tabular lists with varying levels of detail which include:

- Mortality and Morbidity Statistics (MMS).
- Primary care low resources settings (PCL).
- Verbal Autopsy (VA).
- Startup Mortality List (SMoL).

The full name of such a tabular list will always include 'ICD-11', e.g., ICD-11 MMS.

ICD-11: Did you know?

Parenting in ICD-11

An entity may be correctly classified in two different places, such as by site or by aetiology.

For a disease, such as oesophageal cancer, this would mean that it could be classified to cancers (malignant neoplasms) or to conditions of the digestive system.


In the same way, cerebral ischaemic conditions could be classified to the vascular system – where the problem arises – or to the nervous system – where the ischaemia impacts and manifests with symptoms.

In ICD-11 entities may be listed in multiple sites in the Tabular List.


The colour of the text indicates the primary and secondary parent sites.

For example, for oesophageal cancer:

- the primary parent is at malignant neoplasms and the code and title will appear in black
- the secondary parent is at the digestive system and the code and title will appear in grey.


What are other countries doing about ICD-11?

WHO's Western Pacific Regional Office (WPRO) is holding a series of webinars called *Journey Towards ICD-11 in the Pacific*. These webinars are targeted to audiences in pacific island countries and territories in the early stages of ICD-11 consideration.

The first webinar was held on 18 April on ICD-11 *Introduction and Implementation Planning*. It was delivered by ICD experts from WHO Headquarters and WPRO and featured a special presentation by Dr Erwyn Ooi Chin Wei from the Malaysian Ministry of Health, who shared experiences and lessons learned from the ICD-11 implementation in Malaysia.



The second webinar was held on 31 May on *ICD tooling infrastructure* and was again delivered by ICD experts from WHO Headquarters and WPRO, and featured special presentations by Filippa Pretty and Brooke Macpherson from the Australian Collaborating Centre.



A third webinar is planned for the beginning of July.

International Classification of Health Interventions (ICHI) Updates

The WHO announced that ICHI development is reaching its final stages. The WHO advised the World Health Assembly (WHA) in May as follows:

- The ICHI clinical components are stable and already used in some Member States.
- The section on public health interventions is being reviewed. Following that last step, the ICHI will be finalized after a Member State consultation.

The WHO intends to call for Member State feedback on ICHI after the WHA. The process is likely to be similar to that employed for ICD-11 in 2017, in which the AIHW as the ACC provided information to the Department of Health and Aged Care (as the Australian Member State). Pending feedback, ICHI will be presented to the 77th WHA in 2024 for endorsement.

International Classification of Functioning, Disability and Health (ICF) Updates

The ICF has begun to be harmonised into the WHO-FIC Foundation, and work continues to ensure the classification is digitalised onto the WHO-FIC platform. A new version is intended to be released in the second half of 2023, which will incorporate most agreed additions and changes since the last release (2018).

There has been discussion of an adjustment of the CSAC-ICF update processes to align them with the new digital mechanisms (i.e., how proposals can be put onto the platform and how they are managed). Modernisation of the ICF linearisation has been undertaken, which now has capacity to utilise synonyms and search terms to classify similar or related concepts to one code.

ACC ICF Symposium

On 10 May, an ACC ICF Symposium was held, which was attended in-person by close to 50 people, and over 100 online attendees. The Symposium comprised two 90-minute sessions.

Key Australian Government agencies attended, including from the AIHW, Australian Bureau of Statistics, the Independent Health and Aged Care Pricing Authority, the Department of Social Services, and the National Disability Insurance Agency. There were also a range of Australian and international guests.

The primary aim of the Symposium was to provide information about, and explore the potential of, the ICF and its uses (and potential uses) in Australian Government funded services and policies.

15 international and Australian speakers discussed projects in which they had used the ICF and their experiences with the classification. The AIHW would like to especially thank all of the speakers and chairs for their presentations and time.

In the first session (chaired by Michael Frost (AIHW/ACC)), international speakers presented on the value of ICF and their experiences using the ICF in countries such as Japan, Italy, Sweden, and Denmark.

In the second session (chaired by Louise York (AIHW)), Australian presenters spoke about Australian disability data: past, present, and future, potential uses of ICF in administrative data sources in Australia, enhancing casemix systems with data on functioning, as well as a range of projects where ICF has been used in Australia.
